

1. Registration with FinanzOnline

1.1. Getting started with FinanzOnline

Natural persons:

You can get started with FinanzOnline using:

- ID Austria or eIDAS login
- Access data
For information on issuing access data, see point 1.2.

Non-natural persons:

For non-natural persons, the login to FinanzOnline is carried out exclusively using access data (for issuing the access data, see point 1.2.).

After entering FinanzOnline for the first time with the new access data, a supervisor can be created who has all authorizations.

1.2. Issuance of access data

Natural persons:

The disclosure of access data takes place at the request of the natural person or their legal representative. Submitting an application through an authorized representative requires a certified special power of attorney.

The following application options are available:

This option is only available to you if you live in a country where no eIDAS-compliant electronic identification is available.

Non-natural persons:

The disclosure of access data takes place at the request of the legal representative of the non-natural person. Submitting an application through an authorized representative requires a certified special power of attorney.

The following application options are available:

- In person at any tax office
The following documents must be submitted:
 - Registration form '[FON 1](#)'
an English help for the registration can be found here: [FON 1-UK](#)
 - Proof of the power of representation under corporate law (e.g. company register extract, articles of association, statutes)
 - Official photo ID (driver's license, passport, ID card or disability pass)

After successful registration you will receive the following access data:

- Participant identification (TID)
- User identification (BENID)
- Password

The access data is either handed over personally to the tax office or sent with a return receipt letter (RSa).

2. Submission of declarations

2.1. Income tax return

To file your income tax or corporation tax return, select “Eingaben” (entries) from the menu and then select “Erklärungen” (declarations).


