

Registration of the legal entity in the BO Register

Report pursuant to Art. 6 BORA

Receipt of an address change from the central residence register

In the case of reported or automated imported beneficial owners that are marked with ^(bPK), the place of birth, nationality and address will be compared and kept up to date with the Central Residence Register.

In the case of legal persons registered in Austria information about the legal form, business address and existing period will be compared and kept up to date with the respective register: Commercial Register^(FB), Register of Associations^(VR) or Supplementary Register for Others^(ERsB).

Reports or remarks may be made by the legal entity^(RT), an authority^(BEH), an obliged entity^(VPFL) or by the Registry Authority^(RBEH).
